

## 1. DEFINITIONS

<b>Application</b>	Our official website: <a href="http://www.sportsmann.co.uk">www.sportsmann.co.uk</a> , our official application downloaded from any app store or other associated links approved by us whether accessed through mobile telephones or other devices.
<b>Entry</b>	The electronic transmission of a Player's selected position of the football to us. This can only be done via the internet and through our Application where the Entry Fee will be published. To be valid all entries must be verified by our computer system.
<b>Entry Fee</b>	Such sum as we advertise per Entry to be paid from a Player's Account with us.
<b>Finish Time</b>	The date and time on which the Entry closes as specified for each Game on our Application.
<b>Game</b>	Sportsmann's Spot The Ball; a game wherein Players use their own judgment and football knowledge to decide the most likely position of the football in the Image. The Panel use their professional judgment to decide the position of the football and the Player whose Entry is closest to the centre of the football placed by the Panel will win the Prize.
<b>Image</b>	A still image taken from stopping live video footage of a football match and from which we have removed the football.
<b>Panel</b>	The group of experts appointed by us to decide the position of the football; at least two experts from the group will make each decision together.
<b>Player</b>	You or any person making an Entry into the Game.
<b>Player's Account</b>	An account opened by a Player with us to which the Player adds credits for Entry.
<b>Prize</b>	The prize for each Game is as set out in each Game on our Application. There are no cash prizes and no alternatives to the prizes offered.
<b>Terms and Conditions</b>	<a href="#">The Terms and Conditions of Supply</a> that apply to the Game.
<b>Us</b>	Sportsmann Limited; a limited company whose registered office is at 19/21 Circular Road, Douglas, Isle of Man, IM1 1AF with Company Number 124566C. We and Ours are to be similarly defined.

## 2. THE GAME

- A. Entries must be received before the Finish Time for the particular Game. Entries received after the Finish Time will be void.
- B. If by the Finish Time for a particular Game we determine, in our absolute discretion, that insufficient Entries have been received, the Game will be declared void and all Entry Fees will be returned to all Players who entered that Game.
- C. A Player of the Game (using his own judgment and football knowledge) selects the position(s) he or she believes would be where the centre of the football will be placed by the Panel. A Player may place as many entries as he or she wishes paying the Entry Fee for each one.
- D. The Panel uses their professional judgement to choose where they think the centre of the ball is and places a cross into the Image. An automated system decides which Entry is closest to the pixel at the centre of the cross placed by the Panel by moving in a clockwise spiral direction from the judge's pixel.
- E. Our decision with regard to the winning Entry will be final and there is no appeal.
- F. No prize will be awarded to any Player whose Entry is disqualified and any Prize given to a Player whose Entry is later disqualified must be returned to us immediately.
- G. All Winners will be subject to checking against sanctions lists for Politically Exposed Persons. Any Winner who appears on a sanctions list will be subject to management discretion as to whether they are declared the Winner.
- H. Winners will be notified by email and telephone call and the Prize will be despatched within 28 days.
- I. Winners must supply identification to match the information supplied on the Player Account.
- J. If two or more Players have selected exactly the same position, the value of the Prize will be divided equally and alternative prizes to the value of that divided amount will be given to the winning Players. No appeal against the valuation, division or choice of prize is allowed.
- K. Contact with the Winner will be made 7 days of the Game closing. Winners must acknowledge the contact within 28 days or forfeit their prize.
- L. We have unfettered discretion to refuse to accept any Entry where we have a suspicion of dishonesty or the genuineness of the Entry and will refuse Entries made:
  - 1. by persons under the age of 18;
  - 2. by our employees or employees of any associated company or their relatives;
  - 3. by members of the Panel, any of their relatives or companies with which they are associated;
  - 4. by persons involved in the operation of the our Application;
  - 5. by persons acting in concert with those described in (1) to (4) above;
